

# Rules and Conditions of Entry

**Admission is granted and entries accepted only on these terms. Anyone not complying with these rules may be asked to leave.**

1. The organizers, the landowner and his/hers agents shall not be responsible for any loss, injury or damage to competitors, onlookers, their property, helpers or horses or ponies howsoever caused on the premises. **A condition of entry is that all competitors have a minimum of third party public liability insurance.**
2. These competitions will be run under British Dressage rules. All tests are available from British Dressage on 02476 698830 or [www.britishdressage.co.uk](http://www.britishdressage.co.uk).
3. When mounted riders must wear hard hats, properly fastened at all times, to British Standard EN1384, ASTM F1163 or PAS015, or any higher standard in force on the show date. Helmets must have plain, dark colored covers.
4. Classes are limited, with a waitlist kept and riders informed when phoning for start times.
5. **The judge's decision in all cases is final.** Any objection must be made in writing within 20 minutes of the said offence to the show organizers accompanied by a £20 deposit. The deposit will be returned if the objection is upheld.
6. **The organizer reserves the right to cancel any show, alter classes and refuse any entries without explanation.** In the event of cancellation refunds will be made, less £3 per entry form to cover administration.
7. No entry fee will be refunded without a doctor's or vet's certificate and a stamped envelope and address sent to the entry secretary.
8. All horses and ponies must be over four years or older.
9. Please contact organizer if you would like to bring/compete a stallion.
10. Horses and ponies must not be tied up outside horse boxes or trailers and left unattended.
11. No lunging or galloping permitted.
12. Please use bins provided for litter and droppings.
13. In interests of health and safety, everyone must take all reasonable precaution to avoid and prevent accidents and obey instructions of the organizer and stewards.
